The Scheme is operated through our UKAS accredited conformity assessment body Avid Certification Services Ltd and the certification criteria contained within this document have been approved by the Information Commissioner's Office in accordance with the Commissioner's tasks and powers under Articles 57(1)(n) and 58(3)(f) pursuant to Article 42(5) of the UK GDPR.

Age Check Systems are utilised by providers of age restricted goods, content or services to assess and make decisions about the age of customers. This can be through age determination (often called 'hard verification'), age categorisation or age estimation.

PAS 1296:2018 provides a code of practice for age check providers, age exchanges or relying parties undertaking age check processes. As a code of practice, it does not set requirements, but does provide for organisations to make claims of conformity including through independent 3rd party validation of age check systems. In order to do that, it is necessary for the conformity assessment body to set out the technical requirements that it will apply, using PAS 1296:2018 as a framework, to assess whether or not to issue a certificate of conformity.
